    - BRC is working with HC: Professor Bill Sobczak has two seniors working on "dam related" topics. One wants to focus on tree cover around dams; the other wants to look more generally, more as a planner to look at multiple users in the discussion of urban dam removal, interested in headwaters, potentially Poor Farm Dam or Electric Dam in Millbury as real world examples with a lot of the study already done. Nobody wants to keep Poor Farm Dam, and it is on the list that the City wants to remove. I think all it needs is a little political push, but there is no local champion for its removal. → Maybe we can apply to be a DER Priority Project?
    - Stef is working with HC course taught by Bryce DuBois on fish passage over the lower four dams on the Blackstone. His students will be putting together an overview of the four dams, a history

of fish passage permitting/projects, and an overview of the benefits of creating fish passage. They will also be helping plan the 5/21 Fish Passage Migration Parade in Pawtucket.

#### Fish passage:

- The Nature Conservancy (TNC) has a contract in place to do the partial design for fish passage of the lower 2 dams (Main St & Slater Mill), and will continue the other 2 subsequently (Elizabeth Webbing & Valley Falls).
- o RIDEM is also working on this, and Molly Ogren is the meeting coordinator. Stef is working closely with her and will share opportunities for the public to offer comments, support, and other connections.
- RIDEM & TNC have been meeting with dam owners and will schedule additional meetings once their population dynamic study is complete this spring, which will also include a press release, when ready.
   This study and the design process are happening simultaneously.
- O In 2018, Fuss & O'Neil were awarded the contract to do a 30% design with NRCS, then got the contract with TNC to continue this work for all four dams, but are breaking it up. Currently, they're working on delineation, surveying, borings, etc. to create a conceptual plan with permit-ready 60% design within the next year.
- For Slater Mill & Main St dams: They are still working on the QAPP for permit-ready documents, but will
  move on to create bid-ready documents after that. Current considerations are for a single lander over
  land and around Old Slater Mill to not touch the dam itself, but that is not finalized.
- Elizabeth Webbing (owned by RIDEM) and Valley Falls: contractor Fuss & O'Neil will likely continue work on this the year after (2024) to perform exploratory work & explore options for fish passage.
- Stef will be organizing another meeting to hopefully bring tribal members together and hear a comprehensive update on this topic from RIDEM & TNC.
- Needs include potentially creating visualization of what fish passage will achieve, regional benefits (economic, historic, cultural, ecological), potential tours/fact sheets/other outreach products, etc.
- This has been a multi-decade project, and often it's the bureaucracy preventing forward momentum, not lack of technical expertise or even funding. We need to create public support and have this as a legislative and departmental priority for funding, staff capacity, etc. This river runs through some of the most economically disadvantaged communities in the region and we want to create positive changes in the region that support our communities, our history, our indigenous culture, recreational opportunities, and ecological and community health. We believe that there are win-win situations for all stakeholders and will seek out and pursue those.
