- Slater Mill Historic Park was established in 2014, but the National Park Service didn't take over until 2021
- National Park Service owns/operates:
 - Easement on Blackstone River State Park and Ashton Historic Park (they don't own these properties but they have a good relationship with owners)
 - Slatersville Historic District
 - Whitinsville Historic District
 - The Little Red Shop Local Historic District
 - Old Slater Mill National Historic Landmark District
- The Draper Factory in Hopedale was demolished; this is an example of how important it is to preserve these areas through historic districts or designations
- National Park Service does not own the Slater Mill Dam (yet); Old Slater Mill Association owns it including the area that the fish passage would be built on – they're currently pursuing ownership, but it's a long process
- National Park Service cares about:
 - Community engagement
 - Tribal relations
 - Telling the story of the Blackstone region pre-contact and post-contact
 - Opportunities of beneficial environmental actions for the river and valley
 - Finding and creating opportunities for collaboration with partners
 - Presentation and conservation of natural and cultural resources
 - Recreational opportunities on the Blackstone River

- Conservation Law Foundation sued a Millbury scrap facility violating their stormwater permit, resulting in Supplemental Environmental Projects (SEP) being awarded to three entities (dispersed by November)
 - \$50,000 to Blackstone River Watershed Council to improve access at Granite Park in Pawtucket
 - \$50,000 to Blackstone River Watershed Association for education and outreach
 - \$50,000 to Blackstone River Coalition to continue water quality work
 - These funds will be dispersed by November

- [Healey-Driscoll Administration Awards \\$31.5 Million in Climate Resiliency Funds to Communities](#), including CMRPC on behalf of the Blackstone communities of Uxbridge, Sutton, Douglas, and Northbridge; as well as the Hassanamisco Band of Nipmuc. Congratulations to our partners!

- **Mass Audubon** is asking for support for the Connecticut River Watershed Partnership Act (CRWPA), which will create permanent federal funding for conservation, ecological restoration, education, and recreation in the Connecticut River Watershed. The Connecticut River stretches from Quebec to Long Island Sound just west of the Blackstone and supplies drinking water to over 4.8 million people, and provides essential habitat for threatened and endangered species like the Piping Plover and the Short-nosed Sturgeon. - **11/8/23** – [Restoring Fish Passage through Barrier Removal Grant](#) – Aims to provide federal financial and technical assistance to fish passage through the removal of dams and other in-stream barriers for native migratory or sea-run fish.
